# 1. A brief background of the Centre

CUTS was established in the year 1984 with the mandate of pursuing the cause of common consumers. With growth of the organisation, later the responsibility of moving forward with the inherited agenda of CUTS, i.e. consumer protection was handed over to CART, which was established in 1996. The programmes of the Centre are primarily aimed at generating awareness, creating a more responsible society and encouraging changes at the policy level by advocating with the government machinery and sensitising it to its issues of concern to the common man. The Centre has spearheaded several campaigns and pioneered consumer empowerment. It has created and trained over 1200 activists and helped establish over 300 independent groups in Rajasthan and elsewhere. Persistently, CART is having more than 1000 organizations in its network. Its mission is 'to enable people, particularly the poor and the marginalised, to achieve their rights to basic needs, sustainable development and good governance through a strong consumer movement'.

A for Rajasthan <u>Support</u>: Ministry of Environment and Forest, GoI. <u>Theme</u>: Combating Desertification, Land Degradation and Drought Objective: To create awareness on issues related to biodiversity and taking appropriate

action.

Project Period: April 2014-March 2015. (No activity in 2015-16)

#### Main Activities under the Project during the Period

- During the period, activities left over for the period under NEAC 2014-15 like payment to partners, monitoring of programmes, which partners had done and then second installment payments and submission of reports and NEAC newsletter were completed, which went upto August, 2015. # 4.2 <u>Project:</u> Improving Service Delivery by Urban Local Government in the City of Jaipur Through Enhanced Civic Engagement (MyCity-Phase III)

Support: The Asia Foundation (TAF)

<u>Objective</u>: Engaging Community in the Delivery of Key Urban Services in the City of Jaipur.

Project Period: October 2014-September 2015

# Main Activities under the project during the Period (<u>http://cuts-international.org/cart/MyCity\_Phase-III.htm</u>)

- TAF approved MyCity <u>phase III</u> as extension for one more year. Agreement was signed on 23 September 2014 and sent to TAF with a total budget of Rs.21, 00,300/-.
  The details of main activities of phase III during the reporting paried area.
- The details of main activities of phase III during the reporting period are:Rajasthan Mayor's Conference on April 15, 2015
  - Under the project, Mayors' Conference was organised on April 15, 2015 at Hotel Country Inn, Jaipur. Nirmal Nahata, Jaipur Mayor; Mahesh Vijayvargiya, Kota Mayor; Shiv Singh Bhont, Bharatpur Mayor and Inderpal Singh, Deputy Mayor, Bharatpur attended the Mayors Conference and shared various issues of municipalities and their functioning. Prof. V.S. Vyas, Former Deputy Chairman, State Planning Board chaired the discussion, whereas Ramavtar Raghuvnashi, Director, Rajasthan Institute of Local Self Government shared some of the best practices of Municipalities in India. Manish Pareek, Ex Deputy Mayor of Jaipur shared his experiences with MyCity project.
- Community Meetings

Community meetings were organised with the purpose of maintaining regular interaction with the targeted public. Total 48 of such meetings were organised with the support of partner organisations in their respective wards during the period under the supervision of project team. Councilors, JMC officials, representative of RWAs, social workers along with local citizens of ward took part in the meetings and discussed their local issues. Resource material prepared was distributed to participants.

- Partners' Orientation Programme on April 29, 2015 An orientation programme was conducted on April 29, 2015 at Jaipur. Representatives of partner CSOs took part in the orientation. Brief was shared about Rajasthan Mayors' Conference with partners. Partners were also briefed about on-going ward level activities and response of stakeholders.
- Visit of The Asia Foundation, Delhi on May 18, 2015 GC & ADS visited New Delhi on May 18 mainly to discuss the ideas for continues support under urban governance after completion of MyCity project.
- Visit to National Institute of Urban Affairs (NIUA), New Delhi on May 18, 2015 ADS visited NIUA located at India Habitat Centre during Delhi visit on May 18. S.B. Jain, Advisor, NIUA arranged meeting with Dr. Debolina Kundu, Associate Professor. She shared some of the ULBs best practices from Bangalore and Surat.

Public Service Index (PSI)

One of the project activities PSI was conducted during the period. The Public Services Index of each ward was prepared in such a way that it indicates quality of life in various wards by its quality of services and amenities.

<u>Citizen Report Card (CRC) Survey</u> Citizen Report Card is a participatory survey that solicits user feedback on the performance of public services. After orientation on CRC methodology, all partners conducted it on their respective wards and submitted dully filled questionnaires to CUTS. The methodology involved both qualitative (group discussions) and quantitative (survey) tools. The survey sought to examine citizens' satisfaction and experiences in case of services like water supply, sewerage facility, street lights, street roads and solid waste collection and amenities like parks, community halls etc.

Interface Meetings

Interface meetings between community members and service providers including councilor, officials from JMC and other line department were conducted in all 16 targeted wards by the partner CSOs. The objective was to inform participants ward specific data of CRC and to generate discussion upon emerging issues to discuss possible measures to improve the situation of particular locality. It was helpful in establishing a line of communication between the community and service providers at the ward level. The feedback and comments gathered from the interface meetings were incorporated in the findings of the research.

Dissemination cum Advocacy Meeting on August 27, 2015

Final advocacy meeting of MyCity year-3 was organised on August 27, 2015 at Jaipur to share the key findings of project among wider audience of targeted stakeholders. Purushotam Biyani (Director cum Joint Secretary) and Sanchita Bishnoi (Additional Director of Directorate of Local Bodies (DLB), GoR); Mohan Lal Gupta, MLA; Ramavtar Raghuvanshi (Director, Rajasthan Institute of Local Self Government); Bhawani Singh Rajawat, Chairman, Standing Committee (Slum Reforms), Jaipur Municipal Corporation were the special guests of the meeting. More than 90 participants took part including present and former councilors, many officials of JMC from head office and zone offices, representatives of CSOs, RWAs, other civic bodies and media. Monika Solanki of Jaipur Unites also made presentation in the meeting on JMC initiatives.

Mayors' Conference on September 22, 2015

Second Mayors' Conference was organised on September 22, 2015 in Kota. Mahesh Vijay, Kota Mayor; Sunita Vyas, Kota Deputy Mayor, Sanchita Bishnoi, Additional Director of DLB, GoR; Yudhishther Chansi, Councilor, Kota; Vikram Singh, Councilor, Jaipur Municipal Corporation were the representatives of Municipal Corporations. Soumya Chaturvedula, Programme Officer-ICLEI and Sumit Singh, Regional Director, AIILSG were the resource persons and made presentations in the meeting.

Partners' Meeting on September 24, 2015

Representatives of partner CSOs took part in the meeting held at CUTS Conference Hall on September 24, 2015. Meeting was called to share the experiences of implementing MyCity project and challenges faced by them in past. Team also shared their experiences working with partners CSOs. Discussion took place regarding the sustainability aspect of intervention.

#### Study tour of Municipal Government Officials from Ulaan Bataar, Mongolia

15 officials from Municipal Government of Mongolia along with two representatives from TAF India visited Jaipur from December 7-11, 2015 on study tour on urban governance. CUTS organised this visit with the support of TAF, India. This tour included

the in-house sessions on urban governance and CUTS intervention in Hotel Ramada. Visits to Department of Local Bodies, Govt of Rajasthan, Jaipur Municipal Corporation were also arranged to meet the official and understand the scenario of urban governance. Group also participated in the International Conference on Sustainable and Smart Cities (Municipalika) organized by Government of Rajasthan, where they got chance to meet the Chief Minister Vasundhara Raje.

Inception cum Rajasthan Mayors' Conference

First Mayors' Conference under RCMLP was organised on February 17 at Jaipur. Out of 7 Mayors, 5 Mayors and two deputy mayors participated in the conference. Purushottam Biyani, Director cum Joint Secretary, Department of LSG; R.K. Vijayvargiya, Senior Town Planner; Dr. Himani Tiwari, Coordinator, CMAR; B.S. Rathore, Team Leader, SBM. Meeshan Tandon, Senior Manager, ICLEI presented urban intervention of ICLEI in Jaisalmer and Kishangarh and general issues of urban service delivery. Three ULB Chairman from Chittorgarh, Bundi and Baran also participated and presented cases namely Rangde Bundi and Sunehra Chittorgarh.

- Visit to Chennai and Coimbatore, Tamil Nadu to learn urban best practices GC & ADS visited Chennai and Coimbatore cities of Tamil Nadu during March 7-12, 2016 for the learning on urban governance and best practices. They met with Dr. B. Chandra Mohan (IAS), Commissioner and R. Kannan (IAS), Deputy Commissioner of Health, Greater Chennai Corporation (GCC) and discussed urban issues and management during Chennai Flood, sanitation work and other interventions. They also visited Chennai based Citizen Consumer and Civic Action Group (CAG) and discussed their team about the urban governance work.
- GC & ADS also visited Coimbatore city and met with Dr. K. Vijaykartikayen (IAS), Commissioner, Coimbatore City Municipal Corporation (CCMC) and interacted about urban practices and interventions. They met with ICLEI team members and learn more about 'SUNYA Project'. During the visit, a visit of ward 23 was made, which is model ward and met with concern officials like Zonal Sanitary Officer (West Zone) and Sanitary Supervisor. SUNYA Project is based on zero waste management. They also visited Coimbatore Corporation and met with Dr. Santosh Kumar, Chief Health Officer, City Engineer and some other officials.

Workshop on Public Procurement

The first round dissemination workshop was successfully organised on July 07, 2015. The workshop was well participated by the local concerned participants from various departments, CSOs and representatives from World Bank, Assam Procurement Observatory, Department of Finance including Sidhartha Mahajan (Special Secretory, Department of Finance, Govt. of Rajasthan), Shanker Lal (Senior Procurement Specialist, World Bank), Bulbul Sen (Former Chief Income Tax Commissioner and member Expert Group on Procurement in the UN Office of Drugs and Crime) and Dr. Mreeshi Agrawala, Assam Institute of Management (AIM), Guwahati and others took part actively.

Research and Data Analysis

The first phase analysis of data and compiled report got completed and uploaded on the ProOb webportal as well. A research was also conducted to know about the general awareness of the public procurement framework among the common man during the period and the compiled report was completed. Second Round of Workshop

Day long dissemination cum training workshop with key stakeholders on 'Public Procurement Experiences, RTPP Act, Rules and Way Forward' was held on November 30, 2015 at IGPRS, Jaipur. In the meeting, around 130 Public Procuring Officials of various government departments and agencies, entire State Procurement Facilitation Cell (SPFC) at Finance Department, officials from Asian Development Bank (ADB), Resource Person from Competition Commission of India (CCI) a were present in the workshop. In the inaugural session, observatory findings were shared with the SPFC and present stakeholders. Hiroyuki Maruyama, Principal Resident Procurement Specialist, India Resident Mission, Asian Development Bank, New Delhi shared his experiences related to need of public procurement reforms in the South Asia. Arvind Deewan, Chief Accounts Officer and Yogendra Bagda, SPPP in-charge from SPFC team facilitated technical sessions on RTPP Act and Rules in a very effective and interactive way. #### 4.5 <u>Project</u>: Pilot project to promote organic consumption in the state of Rajasthan, India (ProOrganic)

<u>Support</u>: SSNC (Swedish Society for Nature Conservation) Project Period: November 2013-October 2015

<u>Objective</u>: The project is to promote organic consumption in the state of Rajasthan covering six major agriculture potential districts by awareness generation, sensitization, capacity building and advocacy activities. The target districts are Jaipur, Dausa, Udaipur, Chittorgarh, Pratapgarh and Kota. There are total 51 blocks in these 6 selected districts having total 1757 panchayats.

Project Period: November 2013-October 2015

# District Level Consultations (DLC):

The objective of conducting these consultations in all six districts was to discuss the preliminary findings of this action research and to receive the inputs to be used in finalising and preparing the research report and the advocacy document as proposed in the project. The aim of the meeting was also to formulate the strategies for future with farmers so as to come out with much more focused work on the issue in future.

**The first** consultation was organised at Dausa on March 27, 2015. It was attended by 63 participants including KVK in-charge; Assistant Director, Horticulture; District Industries Officer; Deputy Director, Animal Husbandry; farmers; consumers and shopkeepers.

The second District Level Consultation was held at Pratapgarh on April 8, 2015. The DLC was good in terms of participation with little over 50 participants, which included consumers and farmers both. On 15<sup>th</sup> April, 2015, the third DLC in Udaipur was attended by more than 50 participants and experts including KVK officials, Agriculture officer, farmers, consumers and shopkeepers. Similarly, the fourth DLC at Chittorgarh on May 6, 2015, more than 55 participants from 6 blocks of Chittorgarh participated, which included farmers, resource persons and CUTS representatives from Jaipur & Chittorgarh. The fifth Kota DLC was organized on May 14, 2015. The programme was attended by around 63 participants consisting of consumers and farmers both. Radha Krishna Sharma, Agriculture Officer and Khalil Mohd., Gram Sevak and few other government officials spoke in the consultation. The sixth and last consultation at Jaipur on May 29, 2015 was attended by around 55 participants including famers, consumers, experts, researchers, representatives of CSOs from all the 13 blocks of Jaipur. Apart from CUTS team, the key speakers were Dr. B. D. Yadav, Sr. Scientist, Vegetable Department (RARI); Dr. S. Mukherjee, Professor of Horticulture (RARI); Dr S. S. Yadav, Professor, SKN Agriculture University Jobner and Mr. Nathu Lal Meena, (retired agriculture professor) representing Kisan Sangh.

# Submission of entry for 'Best campaigns and advocacy from around the world' for <u>CI</u>

ADS and VAS prepared two presentations on the successful campaigns for submission to Consumers International for showcasing. Presentations were prepared on GAW and Tobacco Control campaigns. Finally the presentation based on the Tobacco Control Intervention in Jaipur City titled 'Tobacco: Deadly in any form or disguise' implemented by CUTS was shared with CI. Presentations were solicited by CI from its member organisations.

#### > Training cum Need Assessment of World Vision Staff

ARS along with ADS and MSS, delivered a half day training cum need assessment session for World Vision (WV) Jaipur Team at Jaipur on April 30, 2015. The participants

included Dr. Josiah Daniel (JD), Programme Manager and Community Development Coordinators working for twenty slum areas of Jaipur city. First session was taken by ARS on need assessment in which he asked participants about their working area, problems and challenges. Based on the feedback on first session, ADS took second session on social accountability, its basics and how it is covered under Citizen Voice Action (CVA). He presented brief introduction of Community Score Card with example of ICDS and MyCity approach on urban governance specific. MSS talked about access to information and general approach of CUTS projects as well. World Vision was happy with the session and asked for a brief proposal for training, research on Child Protection and handholding for their CVA groups.

# > End Line Survey: Selection of Survey Agency

At the end of project, there is an end line survey to assess the project effectiveness and also to collect evidence of change due to the project intervention. In response to call for bids, 5 bids were received. After shortlisting, on July 6, 2015 Partners in Development (PiD) team was selected for the work. The field survey by the agency was completed during the first half of August. Team members made monitoring visits during the survey. The data was later compiled and a final report was prepared and finalized.

#### • <u>Cottage Meetings</u>

During the month of September, 2015, a total number of ten cottage meetings were organised in ten different localities of Jaipur targeting urban consumers. In each of these meetings, consumers were made aware of the importance of consuming organic food. They were also informed about the simple technique of growing organic kitchen garden through the medium of tray cultivation. An expert from Rajasthan Agricultural Research Institute was called up to facilitate as a resource person on the theme of organic food and farming for all. # • <u>Survey</u>

# <u>Stakeholders' Consultation</u>

To mark the conclusion of the Green Action Week Campaign, a State Level Stakeholder Consultation on the theme 'Organic Food and Farming for All' was organized on September 30, 2015 at Jaipur. The aim of the consultation was to advocate for a shift in policy towards organic consumption and production. More than 70 representatives from civil society/consumer organisations, farmers' group, media and government departments participated in the consultation. As speakers, Dr.A.K.Gupta (Rajasthan Agricultural Research Institute), Dr.S.R.Sharma (SKNAU) and Dr. S.S.Rathore from Krishi Vigyan Kendra participated in the consultation.

# > <u>Partner's Feedback Meeting</u>

Partners Feedback Meeting has been conducted on Tuesday, October 27, 2015 at Hotel Royal Orchid. A total number of 8 representatives from our partners have attended the meeting. Partners took active participation in the discussion regarding future activities under ProOrganic.

# State Level Advocacy cum Dissemination Meeting

State Level Advocacy cum Dissemination Meeting was conducted on October 28, 2015 at Hotel Country Inn & Suites, Jaipur. Total 85 participants had attended the meeting.

Dr Shital Prasad Sharma, Director, State Institute of Agriculture Management (SIAM), Govt. of Rajasthan; Dr A K Gupta, Professor and Head, Department of Agronomy, SKNA University, Jobner; Dr S. Mukherjee, Professor and Head, Department of Horticulture, Rajasthan Agricultural Research Institute (RARI), Govt. of Rajasthan; Vardhaman Bapna, Director, Morarka Foundation, Jaipur shared that organic vegetables shops should be established at the Gram Panchayat Level.

# > <u>Strategy Planning Meeting in Stockholm</u>

GC visited Stockholm from October 5-9, 2015 mainly for the strategy planning meeting of SSNC (Swedish Society for Nature Conservation). The meeting was attended by about 40 participants, 20 representatives of partner organisations and 20 staff members of SSNC. Staff from SIDA also attended the meeting in between. 

#### Consumer Complaints Handling, Information & Advisory Services under Grahak Suvidha Kendra

GSK is basically an "advice giving and informal complaints handling mechanism" between the common consumer and three-tier quasi-judicial complaints redressal system that is prevailing in the country. This is basically facilitating an interface (over phone, through email/letter or direct) between the service provider/businesses and the consumer, where grievances are discussed. As a result of such interventions several complaints are settled directly without going to the DCFs. If complaints are not sorted out up to the satisfaction of the consumers, then the centre also provide advice for filing of complaints in the DCFs, State Commissions and National Consumer Dispute Redressal Commission (NCDRC).

During the period, GSK attended complaints and advises as demonstrated through graph below:

Project team consolidated inputs to the Vimarsh team regarding the same. Project team shared the questionnaires with the assistance of Simi TB.

# Rolling Out of the Activities under National Survey by Vimarsh

Tools were designed and questionnaires for service providers and common consumers were prepared in consultation with project team. Vimarsh organised training for research coordinators from all the selected six states on January 28-29, 2016 at its Gurgaon office. All the five coordinators took part in the training programme. MSS also took part on its day two to share his ideas, give suggestions and explain the project background. In this two day training programme, both the questionnaires were discussed one by one to understand its meaning and purpose.

# Signing of the MoU Input Chapters Writers

As part of the final report, five input chapters need to be written by various authors. Five Terms of Reference as per the selected service sector as well as five MoAs has been prepared separately and sent to all the five shortlisted writers who are Simi TB (For Public Amusement Services and Safety), S Saroja (For Energy Services and Safety), Ashim Sanyal (For Transportation Services and Safety), Pritee Shah (For Housing Services including Fire, Earthquake and Lifts and Safety) and R C Sharma and K K Bajaj jointly (For Energy and Safety).

Almost half of the online-shoppers have no clue who the ultimate seller is, finds- a CUTS survey Jaipur: 2015.10.07 Online shopping has become a global phenomenon. In India too we see its adoption grow leaps and bounds. In order to understand the shopping behaviors of consumers, Jaipur-based Consumer Unity & Trust Society (CUTS International), with the support of Retailers Association of India (RAI), Mumbai, recently conducted a survey on the Consumer Buying experiences in three metros viz. Chennai, Kolkata and Jaipur. The survey sample size included 90 consumers with an equal men to women ratio. It was found that as many as 84% consumers shopped both from online and offline marketplaces while just 4% consumers shopped everything online. About 11% consumers preferred only shopping offline. About 62% respondents came to know of the online portals they shopped at through advertisements, 37% through word-of-mouth and 11% from other sources.
