#### A. URBAN GOVERNANCE

# 1. Rajasthan City Mayor's Learning Platform (RCMLP)

**Support**: The Asia Foundation (TAF)

Period: April, 2016-April, 2017

The object is to create a platform of sharing and learning based approaches to enhance knowledge of mayors from various cities of Rajasthan by way of organizing Mayor's conferences, Knowledge Enhancement Workshops and Exposure Visits for Mayors and concerned persons of DLB office.

After so much of efforts, finally a formal platform for City Mayors is created and well recognized by the Mayors of Rajasthan. All Mayors are taking part in the Mayors Conferences and other meetings and considering this is as an important event, which can really enhance knowledge on various topics. Mayors take it as the first ever chance to be at a non-government platform to interact with other city mayors in the State itself. One of the major outcome is that this intervention could enhance knowledge of elected representatives especially of Mayors through sharing of information with each other, which resulted into regular interaction with each other.

# 2. Setting up of Procurement Observatory in Rajasthan (ProOb II)

Support: Asian Development Bank (ADB), New Delhi

<u>Theme</u>: Setting up a Public Procurement Observatory in Rajasthan.

Period: 18<sup>th</sup> April, 2016-17<sup>th</sup> April, 2017

ProOb-2 aimed to improve the public procurement framework of the state by advocating for effective compliance of the RTPP Act, 2012 at all the procuring entities. Strategies, approaches and methodology of intervention and research were also the same as were in first phase. The key activities under the project were maintaining a web portal, reviewing the compliance level of RTPP Act and procurement practices, conducting research on ease of doing business in the selected departments and capturing feedback of common citizenries on procurement related issues and finally advocating with the government and concerned departments for improving the things at their level.

4. Study of Residential Rooftop Solar in Jaipur

<u>Support</u>: World Resources Institute, India Period: November, 2017-January, 2018

The aim is to understand the consumer experience with rooftop solar, specifically, pain points for consumers, who have installed/wish to install rooftop solar in Jaipur.

The project helped in defining the methodology strategies, and indicators observing the procurement process in the selected departments in Rajasthan by way of Procurement Tracking and Analysis of 8600 tenders related to works, goods and services. The findings were shared with the concerned officials of ADB and by way of organizing procurement, orientation dissemination workshops/sessions for the stakeholders and ending up with advocacy workshop with all the government and non-government stakeholders.

This intervention will enhance the internal governance and transparency of organisations to run non-profit activities smoothly in the country for development.

The expected outcome is to increase prevalence of solar rooftops by working to reduce issues people face before, during and after its installation

#### **B. CONSUMER PROTECTION**

# 5. Pilot Project to Promote Organic Consumption in the State of Rajasthan, India (ProOrganic)

**Support**: SSNC (Swedish Society for Nature Conservation)

Project Period: April, 2016-March, 2017 (Bridge Year)

The project aimed to promote organic consumption in the state of Rajasthan covering six major agriculture potential districts by awareness generation, sensitization, capacity building and advocacy activities. The target districts are Jaipur, Dausa, Udaipur, Chittorgarh, Pratapgarh and Kota. There are total 51 blocks in these 6 selected districts having total 1757 panchayats. The activities implemented during the period in order to achieve the outcome of the project were orientations, capacity building of farmers and consumers through trainings and exposures, village level awareness programmes for enhancing the level of awareness of both consumers and farmers and the stakeholder's advocacy meeting in order to bring all the stakeholders at a common platform.

6. Developing a Culture of Sustainable Consumption and Lifestyle through Organic Production and Consumption in the State of Rajasthan (ProOrganic-II)

Support: SSNC (Swedish Society for Nature Conservation)

Project Period: April, 2017-March, 2021

One of the basic idea of the project is to promote sustainable consumption and production, which are important aspects of sustainable regime. This is largely consistent with the environmental and social factors, and education and empowerment of consumers. In 'ProOrganic II' project, focus is on the aspect of sustainable food and farming, and to formulate an agenda to achieve it. This will be acquired through promoting organic production of farm products on one hand, and promoting organic consumption, on the other. Consequently, this would lead to sustainable development in agriculture and environmental sector, as a whole. The target group of the project comprises entire population of the covered 10 districts, 96 blocks and selected 192 gram http://www.cutspanchayats in Rajasthan. international.org/CART/ProOrganic-II/index.htm

The intervention has contributed towards making organic consumption a mass movement in the state of Rajasthan through more awareness to both consumers and producers. This has also helped in involving more stakeholders in the campaign to add value and accountability. The intervention has also contributed in developing more and more demand for organic food by consumers. As a result of sensitization, more farmers also are shifting to organic farming.

Looking to the success of first phase, SSNC further agreed to provide to support for another four years to implement the second phase entitled 'Developing a Culture of Sustainable Consumption and Lifestyle through Organic Production and Consumption in the State of Rajasthan (ProOrganic-II)' from April 01, 2017 to March 31, 2021 in 192 gram panchayats of 10 selected districts of Rajasthan (India).

This report not only includes the safety aspects of several services for consumers but also includes input chapters written by eminent writers.

CUTS jointly with RBI has tried to ensure and able to produce a mass awareness with regard to safe and unrisky investments. Participants in all the workshops did take part with lot of enthusiasm and there was zeal The objective of the pilot programme is imparting education and awareness for the promotion of depositor's interest and to provide safe and secured deposit lessons to various depositors in five selected districts of Rajasthan. In addition, the programme also aimed to encourage public to have a bank account, discourage public from keeping money in illegal nonbank entities, demystify KYC requirements and provide information about customer rights as a depositor.

The purpose of this project is to promote use of safer and sustainable products among low income consumers and in turn improve their health and wellbeing.

# 13. Road Safety Advocacy (ROSA)

<u>Support</u>: Global Road Safety Partnership (GRSP)

Project Period: October, 2016-September, 2017 (Phase I)

Project Period: November, 2017-October, 2019 (Phase II)

The intervention aims to garner support from parliamentarians, media and other stakeholders for supporting smooth passage of the Motor Vehicle (Amendment) Bill, 2016 and post Act, enhancing Road Safety in India through advocacy for speedy rule making and effective implementation of Road Safety Laws in India clubbing it with road safety awareness activities.

The intervention has helped CUTS is coming closer to public representatives and making submissions before Parliamentary Standing Committee through a Bill Blow on the Act. Through advocacy meetings at the national, regional and the divisional level, it has helped imparting and generating awareness on new provisions in the proposed amendments in the Bill. The second phase involves activities in administering road safety activities as well.

# 14. Study of Institutional and Legislative Assessment for Road Safety in India

<u>Support</u>: WHO Country Office for India, through support from Bloomberg Initiative for Global Road Safety (BIGRS 2015-2019)

Period: February-June, 2017

The study aimed to be accomplished in two phases:

# **Phase 2: Conduct an institutional assessment** Objectives:

- 1. To facilitate a common understanding of the roles and responsibilities of government institutions and organizations involved in road safety laws in India, both at the national, State and union territory level.
- 2. To identify the scope and limitations of States' and Union Territories' authority with regards to the adoption and implementation of road safety laws and regulations, within the context of national laws and regulations.

# Phase 3: Conduct a legislative/regulatory assessment in (seven) select states and (three) union territories Objectives:

- 1. To identify state/union territory processes (both formal and informal) in adopting laws and regulation on road safety, specifically with regards to the implementation of the MVA amendment.
- 2. To conduct a comprehensive assessment of laws and regulation for the selected states and union territories leading to the development of recommendations for improvement.

The outcome of the study will help in developing recommendation for improvement for any gaps identified in the assessment in each of the selected States/Union territories, including:

- a. Specific legislative or regulatory text for improvement.
- b. The rationale for the recommendation.

#### 2. HIGHLIGHTS/SPECIAL ENDEVOUR

### Road Safety Week (RSW) in Rajasthan

To commemorate 28<sup>th</sup> RSW, CART organized six Nukkad Nataks at different location in Jaipur City on February 4-5, 2017, which was part of the Road Safety Week (January 30 to February 6, 2017) activities and supported by Dept. of Transport, GoR. Street plays performed was based on the script "Farak Toh Padhta Hai Bhai". Importance of road safety messages was delivered to the masses. Around two thousand people gathered during performing Nukkad Nataks. Spectators appreciated the efforts made by our team. Good Samaritan and Trauma Care guidelines of Supreme Court were part of the script of street plays and were shared with the audiences. #### **Submission Before Parliamentary Standing Committee (PSC)**

The report of the PSC on Transport, on the Motor Vehicle (Amendment) Bill 2016, was tabled in parliament on February 8, 2017. Almost all the suggestions in the submission made by CUTS before the Parliamentary Standing Committee on November 4, 2016 were incorporated in the report and CUTS name was mentioned in the report. CUTS was the only organization, which advocated for fixing accountability for flaws in road designs, resulting in frequent accidents. That point was also included in the final report of PSC. CUTS Bill Blow Up/submission was referred by the committee on several occasions.

#### National Human Rights Based Approach Follow Up Workshop

Under ProOrganic II, as part of incorporating Human Rights Based Approach into CUTS management and programmes, SSNC has initiated an assessment of CUTS in the year 2015. For the assessment, external consulting agencies were hired to conduct two back to back workshops in 2016. The purpose of the assessment was to map the Human Rights Based Approach (HRBA) employed by CUTS in it work to strengthen accountability, transparency, active and meaningful participation, non-discrimination and the issue of empowerment for all its beneficiaries of the project. The aim was not only to assess the extent of changes produced by the project but also to identify contextual factors, opportunities for cross-linkages and enabling factors that can strengthen the integration of a HRBA and Gender Equity approach in subsequent programmes. In continuation, CUTS as part of its ProOrganic II Project has proposed organised a Follow-up Workshop on December 8, 2017 at Jaipur for the project partners and other stakeholders involved in the implementation of ProOrganic II project in their respective areas. Centre for Dalit Rights, a Jaipur based NGO facilitated the one-day training to all the partners.
