Main objective of the project is to fill the identified gaps and sustain the acquired momentum to achieve expected outcomes of better eco-system through promotion of organic consumption by way of developing a culture of sustainable development through sensitization, awareness generation and education on organic consumption and production.

Green Action Week-Rajasthan Campaign, 2019

Period: September, 2020-January, 2021

Green Action Week (GAW), observed each yea during the first week of October, is a globa people's campaign to promote sustainable consumption. Around 50 organisations in 30 countries in Africa, Asia, Europe, North- and Soutl America are participating in the campaign in 2020 Green Action Week is an initiative by the Swedisl Society for Nature Conservation (SSNC) and i carried out in India coordinated by CUT International, a global consumer advocacy group headquartered in Jaipur.

"Sharing Community" is the theme for the campaign in 2020. Since 2018, campaign has focused on encouraging cultures of sharing and collaboration. This year campaign will discuss and implement ways that can bring more equal and sustainable access to goods and services for the benefit of the people and the planet, through sharing and collaboration.

The fourth year of the activity though has been hit by pandemic drastically but inspite of this, the activities as planned for the year 2020-21 have been implemented with each and every task taken up as a challenge in the field. The vear of 2020 started with the remaining activities of 2019-20 and finally a Stakeholder's Consultation in the month of March, 2020. Then the 2020-21 activities could start only after the end of lockdown, with mainly the online activities in the form of webinars. Later, from July onwards, the team started moving to field and accomplishing major tasks as envisaged in the year's work plan. This includes an exclusive plan of awareness activities on pandemic in the ten districts. the budget for which was culled out from the remaining activities of 2019-20. In a run up to it, the other planned activities of the year 2020-21 too started smoothly and is still in the process scheduled to be completed by March, 2021. Focusing on the theme, activities were planned in Jaipur covering mainly the area of Panchyawala, Triveni Nagar, Sanganer & Dhawas. The activities, which are planned are 'Awareness Meetings to Strengthen the Six Established E-Waste Bins'; 'Establishing 100 Kitchen Gardens'; 'Organising Cottage Meeting' with triggering sessions; 'Strengthening the Established Wall of Kindness (Saaniha Ki Deewar)' and Library'; 'Organising Community Community Level Stakeholder Consultation'; 'Printing and Distributing IEC Material' and organising 'Final Stakeholder's Consultation'. Like in previous years, this time also, the activities were extended to all the ProOrganic II districts and Banswara.

Though, the campaign, which should have been completed by end October has been delayed and now would be over only by January 2021 with the State Level Stakeholder's Consultation as the final meeting.

2. HIGHLIGHTS/SPECIAL ENDEVOUR/EVENTS

ProVoice: CI-IKEA Foundation Supported Project

The project activities got concluded on ground by January 31, 2020. The final narrative report and SoE along with the several supporting reports and other documents, submitted to CI before deadline.

Depositor Education and Awareness Programme

In a series of ten programmes being organized in the third round of Phase II of RBI supported Depositor's Education Awareness Programme under DEAF, during 2020, the seventh DEAP was organized on January 10, 2020 at Pratapgarh with around 65 participants. The programme was well organized with good number of bankers also apart from participants. M P Kothari, ex-Regional Director, RBI was the key resource person. Similarly, the eighth, ninth and finally the last and the tenth DEAP were organized on February 7, 17 and 27, 2020 at Kurgaon; Hindaun City and Mahaveer Ji all in Karouli district respectively. DEAP at Kurgaon in Karouli district with 60 participants and three bankers, BoB, PNB and LDM of BoB. Similarly, in Hindaun City with nearly 65 participants, this time mostly students accompanied by local businessmen and other people. Five

bankers from Bank of India; State Bank of India; Union Bank of India, Bank of Baroda and Punjab National Bank and lastly in Mahaveer Ji with around 46 participants and FIDD nominated LDM of Bank of Baroda and branch manager, PNB. Road Safety Advocacy

Capacity Building Workshops on Five Key Risk Factors for Enforcement Officials

Under the ROSA project, total five capacity building workshops were organised during 2020. Out of the total five, three were organised in Kerala state i.e. on January 13, 2020 at Kannur; on January 17, 2020 at Thiruvananthapuram and on February 24, 2020 at Ernakulum. Similarly, in Rajasthan in Jaipur on February 5, 2020 and second in Ajmer on February 6, 2020. In Kerala, workshops were organised in collaboration with Kerala Road Safety Authority and Centre for Environment and Development, Thiruvananthapuram and in Rajasthan, these were organised in association with Department of Transport of Govt. of Rajasthan. The focus of these capacity building workshops were five key risk factors, which includes Drink and Drive, Speeding, Not Wearing Helmet, Seat Belt and Child Restraint System. All these are behavioral risk factors, which causes maximum road accident deaths and injuries. The other sessions were on Intelligent Transport System, Effective Trauma Care and Road Signs. In each of the workshop, there were around 45-50 officials deputed by Transport Department, Traffic Police and medical and health department. State Level Feedback and Stakeholder's Consultation and World Consumer Rights Day

The ProOrganic II project activities for the year 2019-20 got culminated with a State Level Feedback and Stakeholder's Consultation for the year 2019-20 at Jaipur on March 13, 2019. As usual, the purpose of this final activity of the year was to critically analyse the boons and banes of activities implemented in last one year including the achievements and the targets. The event comprised two sessions: the inaugural and technical. The key speakers in the meeting were Dr. A.K. Gupta, Director, Research, SKN Agriculture University, Jobner, Jaipur; R.K. Yadvendra, Joint Director, Department of Agriculture and Dr. Gajendra Sharma, Research Officer, Department of Agriculture both from Govt. of Rajasthan.

As this occasion was clubbed with the commemoration of World Consumer Rights Day, 2020 and the theme of this year's WCRD is also 'Sustainable Consumer', so the event started with an address by George Cheriyan stating the importance, history and purpose of WCRD bringing it down and clubbing it with project objectives and the overall status and future scope of sustainable consumption worldwide. Rajdeep Pareek made a presentation on last year's activities with some very key achievements as part of project outcome over last one year. The event was attended by around 72 participants covering all the district partners of ten project districts and a progressive farmer, local NGO and CSO reps. and media. DD, Jaipur covered the event. The event was conducted with extra care taken while following advisories in the wake of Corona spread.

Commemoration of World Food Safety Day

Food Safety, Everyone's Business

Everyone has the right to safe, nutritious and sufficient food. Still today, almost one in ten people in the world fall ill after eating contaminated food. When food is not safe, children cannot learn, adults cannot work. Human development cannot take place. Safe food is critical to promoting health and ending hunger, two of the primary

goals of the 2030 Agenda. There is no food security without food safety and in a world where the food supply chain has become more complex, any adverse food safety incident may have global negative effects on public health, trade and the economy. Yet food safety is taken for granted. It is often invisible, until you get food poisoning. Unsafe food containing harmful bacteria, viruses, parasites or chemical substances, causes more than 200 diseases–ranging from diarrhoea to cancer. This international day is an opportunity to strengthen efforts to ensure that the food we eat is safe. Whether you produce, process, sell or prepare food, then you have a role in keeping it safe. Everybody along the food chain is responsible for food safety.

To commemorated the World Food Safety Day, CUTS CART team gathered in the conference room on June 5, 2020 and shared the key messages related to the theme 'Food Safety, Everyone's Business' and called to action through project dedicated social media pages.

Participation in SCORAI Conference on June 10-12, 2020

The 4th International SCORAI (Sustainable Consumption Research and Action Initiative) conference was jointly organized by Northeastern University (School of Public Policy and Urban Affairs) and the KTH Royal Institute of Technology on June 10-12. Due to the pandemic, conference was a fully digital conference The theme for the 2020 conference was 'Sustainable Consumption & Social Justice in an Urbanizing World'. George, Amar Deep, Madhu Sudan, Amit and Simi attended several sessions in the conference and prepared the brief reports. Amar Deep prepared the posters for submission with George. Consolidated report was finalised and submitted to SSNC on June 15, 2020 for the information and sharing with other think tank members. George was ranked first among active members. Pre-Conference session was attended by George and Amar Deep on June 8, 2021 with other Think Tank members of SSNC.

CUTS Awareness Campaign on Good Hygienic Practices in Rajasthan

CUTS International, as part of its Covid-19 response activities, organised a massive awareness campaign in the State, Rajasthan. The purpose of the campaign was to educate people residing in villages, hamlets, mainly the rural population about good hygienic practices, physical distance maintaining habits, providing tips for safe food practices and other basic health tips. The public was apprised of the need to remain alert, follow all health protocols and save them from getting infected.

It was the time, when people were not aware of pandemic protocols and other safety measures. As a result of which, they were not taking this pandemic seriously, especially in the rural areas during the unlock process. People were found moving around without wearing masks, crowd was gathering in marriages and other functions, proving conducive environment for the virus to spread. Therefore, there is a need to make the people more and more aware about the measures to prevent this virus spread, so that they can save themselves, their families and the community from this pandemic. Hundreds of persons from rural areas of Rajasthan were benefitted from the massive fortnight long awareness campaign, which consisted of 50 awareness activities in 11 districts of Rajasthan from July 1 to 15. These districts were Jaipur, Dausa, Sawai Madhopur, Bhilwara, Chittorgarh, Pratapgarh, Jaipur, Kota, Jhalawar, Jodhpur and Banswara.

The state level launch of the activities was held in Chittorgarh and events were held in various districts. Various dignitaries such as Ankit Kumar Singh, District Collector, Banswara; Mukesh Kalal, Additional District Collector Chittorgarh; Mrs. Sarita Singh, Additional Superintendent of Police Chittorgarh; Sanjeev Sharma, Sub-Divisional Magistrate, Kota; Ratan Lal Regar, Sub-Divisional Magistrate, Jodhpur; Sanket Modi, Deputy Labour Commissioner, Bhilwara; Dr. B. L. Jat, Scientist, KVK, Dausa released the IEC materials of the campaign at various functions, and attended various events along with Sarpanchs, representatives from the Gram Panchayats, representatives from the health Department, ANM and Asha Workers, community leaders,

This change has occurred because of the changing eating habits of consumers, who are turning to organic foods in order to enhance immunity against Covid 19.

In order to take better cognizance of this development, CUTS International organised a webinar on 'Role of Organic Products/Organic Farming in Dealing with the Pandemic' on August 21, 2020. The main speakers were Dr. S. K. Sharma, Zonal Director, Research, MPUAT, Udaipur; Dr. A. K. Sharma, Principal Scientist, CAZRI, Jodhpur; Virendra Parihar, Programme Producer, DD Kisaan Channel, Doordarshan Kendra, Jaipur and Rohit Jain, Secretary, OFAI. Deepak Saxena moderated. Nearly 103 participated, which includes farmers from project districts. Celebrating World Heart Day on September 29, 2020

Every year on September 29, World Heart Day is celebrated. With increasing cardiovascular illness, the day is to bring people attention to the increasing number of heart illness. The day is there to promote different preventive steps. Its primary goal is to spread information about a quality lifestyle. More than 17 million people die due to heart illness every year. This number is increasing constantly. A significant reason is busy and bad lifestyle followed by individuals. It looks like, we have given up on our health. CUTS celebrated the World Heart Day and conducted a sample online survey on September 25-27, 2020 of 12 districts among common consumers about general awareness about the Trans Fats, Harmful effects of Trans Fats, sources of TFAs, role of FSSAI in regulating the TFA sector and relevant law making etc. Finally, the survey results came very interesting findings, which were very well picked up with the national media, PTI, UNI, APN news agencies in addition with several online newspaper editions covered the news, which became national news.

World Day of Remembrance on November 12, 2020

The World Day of Remembrance for Road Traffic Victims was started by Road Peace in 1993. Since then it has been observed and promoted worldwide by several NGOs and its associated organizations. On October 26, 2005, the United Nations endorsed it as a global day to be observed every third Sunday in November each year, making it a major advocacy day for road traffic injury prevention. WHO and the United Nations Road Safety Collaboration encourage governments and NGOs around the world to commemorate this day. Under Road Safety intervention, CUTS virtually commemorated the WDoR, 2020 on November 17, 2020. CUTS team reached out to Pratap Singh Khachariyawas, Transport Minister, Rajasthan, Ravi Jain, Transport Commissioner, Rajasthan and Anand Siddhu, Deputy Commissioner of Police (Traffic), Jaipur on this occasion. Team prepared

placards of key road safety messages and took photographs with all the mentioned dignitaries. All the dignitaries appreciated CUTS efforts being made for road safety victims in Rajasthan.


Lights for Defenders Campaign on December 10, 2020
