## New Innovations Required for Sustainable Urban Governance

“All stakeholders need to work together to strengthen the urban governance in Rajasthan through research, capacity building of local bodies,” said Hridesh Kumar Sharma, IAS, Director cum Joint Secretary, Department of Local Self Government (LSG), Government of Rajasthan. He inaugurated the expert consultation organised by CUTS International on September 02, 2022, under a project entitled ‘Improving City Governance through Enhancing Knowledge of Urban Local Bodies in Rajasthan’ supported by the Australian High Commission under its Direct Aid Programme.

He further added inclusive and sustainable governance is the need of the hour, and LSG is working towards improving the performance of local bodies. Sharma highlighted that urban growth should be inclusive, safe, resilient, and sustainable and appreciated CUTS’ work in urban governance.

George Cheriyan, Director, CUTS opined that Rajasthan’s urban population is around 1.70 crores, 24.9 per cent of the total population. In contrast, the rural population stands at 5.15 crore, 75.1 per cent of the total population. Such a rise in urban population implies increased demand for goods and services and the requirement of efficient systems for urban planning, management and governance. Therefore, addressing urban development and transformation, urban inequalities and bringing suitable reformation within the urban governance system to address these changes are India’s most important political and intellectual challenges.

Dachepally Sudhakar, a Former Executive Engineer of Hyderabad Municipal Corporation, highlighted the best practices of Greater Hyderabad Municipal Corporation. He said there is a need for innovation in urban issues like municipal finance, urban public transportation, sanitation, and community participation.

Dharmendra Bhatnagar, Team Leader, Rajasthan Shahari Vikas Kendra, said resident welfare associations (RWAs) need to be strengthened like other metro cities. Political will is required to achieve sustainable urban governance.

BR Sharma, President Federation of RWAs, said LSG should include RWAs in every urban governance scheme and city planning. Seema Joshi, a Former Member of the Rajasthan State Child Protection Commission, highlighted that the city should be child friendly by incorporating ideas of the proper footpath, bicycle tracks, and space for recreation.

During the meeting, Himani Tiwari, City Managers’ Association, Rajasthan (CMAR), Department of Local Self Government, highlighted the government’s initiative and programme related to urban governance.

Amar Deep Singh, Senior Programme Officer CUTS, presented the organisation’s previous work on urban governance and explained the objective and activities of the project. He said CUTS would organise capacity-building programmes to improve urban governance in different parts of Rajasthan in identified areas. He shared key findings of the study done by CUTS for identifying the areas that required the capacity building of ULBs.

Amit Babu, Programme Associate, CUTS, proposed the vote of thanks. The meeting saw the participation of more than 35 senior officials of the LSG Department, experts in urban governance and RWAs.

During the occasion, an MoU was signed between the Department of LSG and CUTS International to build capacity building of ULBs.



## Experts Demanded an Effective Mandatory Warning Label

Public health and consumer experts in Rajasthan unanimously demanded mandatory simplified front-of-the-pack labelling (FoPL) regulation to be notified by the Food Regulator at the earliest to address the rising Non-Communicable Diseases (NCDs) in the country. Experts unanimously proposed this in a state-level consultation on 'Status of NCDs and Role of Front of the Pack Labelling' organised by CUTS in Jaipur to generate awareness on FoPL and its role in curbing NCDs among wider stakeholders.



Cheriyann said FoPL is a cost-effective messaging strategy to help consumers make informed, healthier food choices. It allows consumers to correctly, quickly, and easily identify products that contain unhealthy ingredients such as sugar, salt and fats. One of the primary reasons for increasing NCDs is poor dietary behaviour. Therefore, he stressed that the food regulator in India needs to move forward at a more rapid phase to choose an ideal label for packaged food products for consumers in India.

Sunil Sharma, IAS, Food Safety Commissioner, Directorate of Food Safety and Drug Control, Government of Rajasthan, stated that government officials and health department employees are still unaware of this critical issue of NCDs and FoPL. Sharma emphasised the need to spread awareness among all consumers and healthcare providers. He highlighted that consumers have a right to get accurate information about their products. Sharma agreed to the idea of a warning label for a country like India.

Dr Ashok Gupta, Professor and Head, J.K. Lone Hospital, Jaipur, highlighted that Rajasthan is in the red zone in NCD cases, and this is the right time to understand the real cause of diseases due to unhealthy diets. He claimed proper eating habits could reduce a large number of deaths.

Sanjay Pandey, National Consultant, Global Health Advocacy Incubator, underlined the importance of the warning label in India. He highlighted that the nonlinear nature of NCDs necessitates a multidimensional approach to addressing the issue. According to him, consumers are misinformed and confused by the health star rating.

Satyapal Singh, Programme Officer, CUTS, delivered a presentation on the status of the NCDs and the role of FoPL in Rajasthan and across the country.

The panellists in the technical session were: Dr Seema Mehta, Indian Institute of Health Management Research (IIHMR) Public Health Department; Dr R.N.Meena, State Nodal Officer, NCDs, Department of Health, Government of

Rajasthan; Vandana Vyas, Member In charge, Health & Nutrition Cell, Rajasthan State Commission for Protection of Child Rights (RSCPCR); and Kanika Verma, Professor, Department of Nutrition, Rajasthan University, who shared their department-specific progress and programmes related to the NCDs.

In the closing session, Madhu Sudan Sharma, Senior Programme Officer, CUTS, summarised the deliberations and proposed a vote of thanks. About 50 participants attended.

The State level consultation in Kerala on 'Significance of FoPL in Addressing NCDs' was organised jointly by CUTS and National Resource Centre on NCDs and in collaboration with the Directorate of Health Services, Government of Kerala in Thiruvananthapuram, on August 26, 2022.

Johnson Edayaranmula delivered the welcome address, and Cheriyann made the opening address. Lt. Col. L J John, Regional Director, Food Safety and Standards Authority of India (FSSAI), Ministry of Health and Family Welfare, Government of India, delivered the keynote address. Dr V Meenakshi, Additional Director of Health Services (Public Health), Government of Kerala and Saju V Itty, Executive Director of Kerala Voluntary Health Services, delivered special addresses.

In the technical session, Simi T.B. made the introductory presentation. The panellists were Bipin K Gopal, State Nodal Officer, NCD, Directorate of Health Services; Dr A.S. Pradeep Kumar, Former Additional Director of Health Services; Dr K R



Antony, Independent Monitor, National Health Mission and Dr V.R. Vasundhara, Medical Officer, Government Nature Cure Hospital, Varkala.

Dr Sreejith N. Kumar, Indian Medical Association (IMA) was the chief guest in the valedictory session and Dr Geomcy George summed up the deliberations. More than 50 participants, including 25 doctors, attended the consultation and agreed that a warning label is more effective.

जयपुर, 14 दिसंबर : इंडियन नेशनल काँग्रेस के निदेशक जॉर्ज चेरियन 9 दिसंबर, 2022 को जयपुर, झारखण्ड में हुए चुनावों के दौरान भारत के उपभोक्ता समन्वय परिषद (सी.सी.सी.) के उपाध्यक्ष पद के लिए पद छोड़ा है। सी.सी.सी. के संविधान के अनुसार, चुनाव दो साल में एक बार होता है और उपाध्यक्ष बनने के बाद, दो साल बाद स्वतः रूप से सी.सी.सी. का अध्यक्ष बन जाता है। चेरियन ने 22 विभिन्न राज्यों के निधियों में राष्ट्रीय उपभोक्ता समलेन (सी.सी.सी.) की वार्षिक आम सभा में भाग लेने के चरणों में शामिल हुए।
