Enough is Enough:

The Persistent Threat to Female's Safety



India, a country renowned for its cultural diversity and rich heritage, has been grappling with an alarming issue: the safety and respect of its women. Despite significant strides in various fields, the nation continues to be plagued by disturbing rates of sexual violence, harassment, and discrimination against women.

The cases of Abhaya and Nirbhaya, two young women who were brutally raped and murdered, have left an indelible mark on the nation's conscience.

The rape of the young doctor in Kolkata has brought to the forefront the pervasive threat faced by women in India. The brutal nature of the crime, which perhaps involved multiple assailants, has sent shockwaves across the country. The incident has reignited calls for justice and raised questions about the effectiveness of measures to prevent such heinous acts.

According to the National Crime Records Bureau, the number of crimes against women has been on the rise in recent years. 31,677 rape cases were registered across the country, or an average of 86 cases daily. Cases of rape, sexual harassment, and domestic violence continue to dominate headlines, sparking widespread outrage and calls for stricter measures to protect women's rights.

While the government has implemented various initiatives to address the issue of women's safety, including the Nirbhaya Fund and the establishment of women's police stations, much remains to be done. The deep-rooted societal attitudes and cultural norms that perpetuate gender inequality and discrimination must be challenged and changed.

What's even worse is the rape of infants which is mostly done by neighbours, family members, or fathers. The perpetrators of these crimes must face the harshest possible punishment which should send a strong message throughout society.

The death penalty, while a controversial measure, should be considered in cases of extreme brutality and where there is no possibility of rehabilitation. The state must send a strong message that such acts will not be tolerated and that justice will be served.

The safety and well-being of females cannot be compromised. It is a fundamental human right that must be protected at all costs.

Sell scrap with JMC-Heritage's new mobile app

JMC-Heritage has introduced 'Recycle Jaipur', a mobile app enabling residents to sell household scrap for recycling. It covers items like e-waste, appliances, books, and newspapers. A ₹30 service fee applies, waived for higher-value items. Collected waste is segregated and sent to recycling plants for processing.

Rajasthan's Denial of Relief

The Congress accused the BJP government in Rajasthan of retracting Prime Minister Modi's promises by discontinuing reliefs, including a scheme offering 100 units of free electricity to domestic consumers. Former Chief Minister Ashok Gehlot highlighted that this decision would affect around 30 lakh consumers, contrasting with the Congress regime's relief to 1.04 crore consumers.

Farmers in Rajasthan remain frustrated by a severe water crisis, inadequate MSP for crops, and

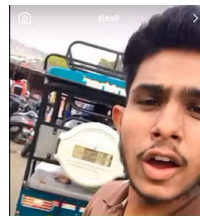

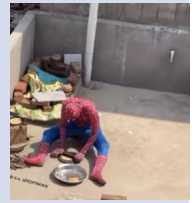

Rajasthan Cities Lag in Air Quality

In the Swachh Vayu Survekshan 2024, Rajasthan's major cities underperformed in air quality management, with Jodhpur ranked 34th, Jaipur 37th, and Kota 42nd. The survey revealed a lack of awareness among local bodies regarding rankings, emphasising the need for coordinated efforts to enhance air quality across the state.

On the second anniversary of Mahsa Amini's death, women across Iran defied hijab laws in

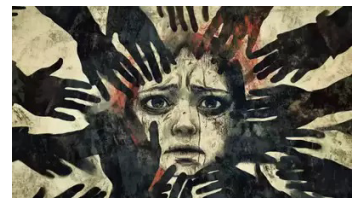

Pollution Raises Death Risk

A study by researchers, including the International Institute for Population Sciences, found that PM2.5 pollution exceeding India's



national standards significantly increases mortality risk across all age groups. The combined impact of ambient and household air pollution further heightens this risk, particularly for newborns and children, stressing the need for cleaner fuel and kitchens.

21 Cities Under NCAP

Ninety-five of 131 cities under India's National Clean Air Programme (NCAP) has improved air quality, with 21 reducing PM10 pollution by over 40 percent compared to 2017-18 levels. However, only 18 cities meet the National Ambient Air Quality Standards. Surat, Jabalpur, and Agra were recognised for air quality improvements at the Swachh Vayu Survekshan - 2024.

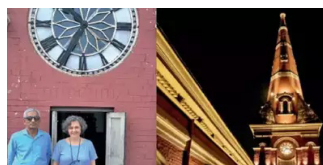
Finland is the Happiest Nation

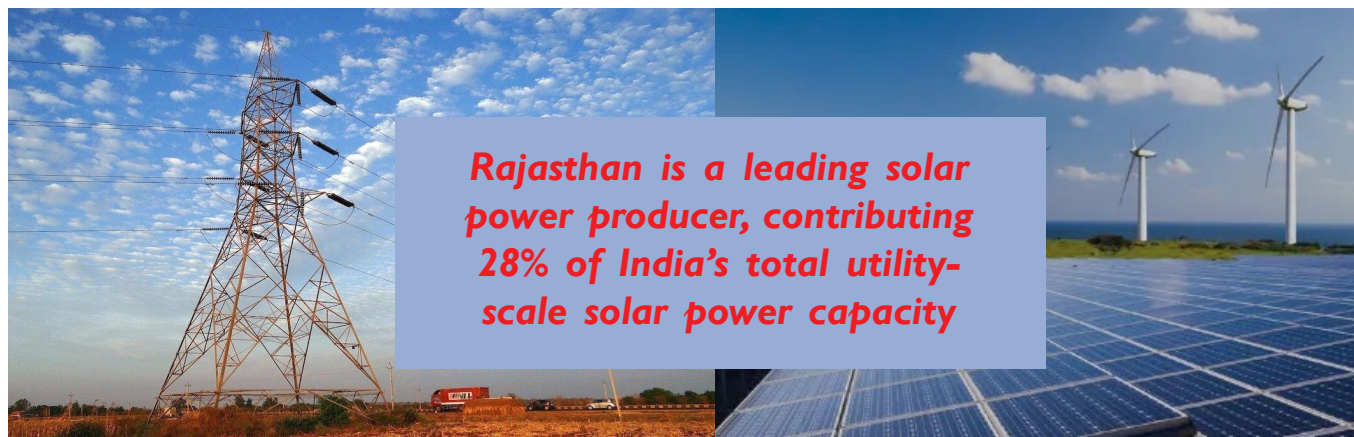
Nagaon; Protesters Hit Streets

Rajasthan Needs Power Reforms

Carrying coals to Newcastle is the closest metaphor to Rajasthan importing coal from the distant Chhattisgarh for thermal power stations in the state. What would make more sense is that Rajasthan could promote power plants at the pithead and carry power through the national grid.

Fortuitously, the coal ministry is planning such pithead plants with a capacity of 5,000 megawatt (Mw) in the coalfields of Chhattisgarh, Odisha, and Jharkhand with a total generation capacity of 30 gigawatt (Gw) through partnerships with public and private sector players. What Rajasthan could do is establish power plants around coal mines and auction them to the private sector for tariff-based bids. An ever-increasing electricity demand, coupled with inefficient utilities, paints a lacklustre future, underscoring the need for immediate and comprehensive reforms in the state's power sector.

Rajasthan is a leading solar power producer, contributing 28% of India's total utility-scale solar power capacity. Despite being power-surplus, the state struggles to meet its renewable purchase obligations (RPOs) due to financial issues and lack of confidence in state utilities. The state's electricity regulatory commission also needs to ensure discoms' compliance with RPOs.

Without RPO compliance, thermal power remains the major source of electricity in a state with no coal reserves. Most of its coal is transported from Chhattisgarh or imported, significantly increasing the landing cost of coal. In 2024 alone, the Rajasthan Rajya Vidyut Utpadan Nigam (RUVNL) is set to procure 0.4 million metric tonnes of imported coal at ₹12,780 per tonne, resulting in an additional financial burden of ₹430 crore. This expense is likely to translate into a fuel surcharge of ₹0.35-0.4 per unit for consumers.

Recent trends show a 25% increase in electricity consumption from May 2023 to May of this year. This rising demand is driven by a growing economy and climate change effects, leading to a heavier reliance on thermal power due to poor utility conditions. The interstate transmission network can be used to evacuate power from pithead plants to Rajasthan.

The Centre has approved a new power transmission scheme to evacuate 4.5 Gw of RE from Rajasthan with a financial outlay of ₹122 billion. Rajasthan aims for 90 Gw of RE by 2030, but this requires revitalising the regulatory framework governing discoms. Additionally, the Mahi Banswara nuclear power plant, proposed in 2018, and lignite-based electricity generation in Rajasthan offer promising avenues to enhance energy security.

However, despite advancements in fossil fuel technologies like the integrated gasification combined cycle, these plants fall short of RE sources such as solar and wind in terms of economic viability and environmental benefits. Therefore, a balanced approach is crucial to address both energy security and the imperative to reduce greenhouse gas emissions.

If thermal power is expected to remain the mainstay of power generation in Rajasthan for the foreseeable future, the state must pursue sensible action to ensure a long-term cost-effective strategy, such as pithead plants on a public-private partnership basis, to develop resource supply chain resilience.
