# Tackling Plastic Pollution: World Consumer Rights Day 2021

March is World Consumer Rights Day, an annual occasion for celebration, impact and global solidarity within the international consumer movement. Welcoming the participants and the speakers, Deepak Saxena, Assistant Director, CUTS International, said that each year, consumer organisations mark the day by joining together to highlight and raise awareness of an important issue to consumers worldwide. Saxena also remarked that around 240 organisations are commemorating this day in 209 countries and each year, it is focussed on a dedicated theme.

In an organised way, the World Consumer Rights Day (WCRD) first took place on 15 March in 1983 organised by the International Organisation of Consumer Unions (IOCU) and has now become an annual event for solidarity within the international consumer movement along with creating awareness about consumer rights. Since 1995, Consumers International is responsible for coordinating this event at the international level. This year, the theme is 'Tackling Plastic Pollution'.

In his opening remarks, George Cheriyan, Director, highlighting the theme, elaborated that plastic waste is India's and the world's most formidable (difficult to deal with) environmental challenge today. COVID-19 pandemic has made matters worse. According to World Economic Forum, the world produces more than 400 million tonnes of plastic every year. Enunciating with another study, Cheriyan

said, 79 percent of the plastic made (316 million tonnes) in the world enters our land, water and environment as waste; some of it also enters our bodies through the food chain.

In a run-up to the World Consumer Rights Day celebration, CUTS also earmarked this day as the State Level Stakeholder's consultation of its ongoing project ProOrganic in ten districts of Rajasthan. On this occasion, Rajdeep Pareek, Programme Officer, CUTS presented 2020-21 year's activities with key highlights and major outcomes and recommendations.

A S Baloda, Director, Rajasthan Agriculture Research Institute, reiterated the need for a constant campaign on organic farming. Farmers and consumers should also understand its importance in the longer run. Shailendra Chauhan, Assistant General Manager, National Bank for Agricultural and Rural Development (NABARD), spoke on various schemes for organic farming.

Padma Shree Awardee Jagdish Pareek narrated some essential tips on organic farming in his simple style and language. Deepika Saini, Quality Manager, Rajasthan State Organic Certification Agency, provided tips to participating farmers on organic certification.

Those who had displayed their organic products through the exhibition and other farmers attending the event switched from chemical to organic farming. All the farmers were given mementos as a token of appreciation by CUTS for their organic farming efforts.


### Grahak Sahayta Kendra, Jaipur

# Organic Consumption and Sale: A Growing Trend Amid the Pandemic



91 percent of organic sellers and 89 percent of consumers have confirmed that there has been substantial growth in both sales and the consumption of organic products during the pandemic. CUTS International surveyed the sellers and consumers of organic food products in ten districts of Rajasthan. 2000 samples of consumers (200 per district) and 200 sellers, including retailers and distributors but producers (farmers), were not included. Around 62 percent of sellers have confirmed selling organic products along with other non-organic products. 86 percent of consumers feel that the changing pattern of organic consumption must carry on in the future.

### **Road Safety Award to RSRTC**

Rajasthan State Road Transport Corporation (RSRTC) has received the Road Safety Award for minimal accidents. The Union Road Transport and Highways Minister have honoured Rajasthan Roadways by giving Road Safety Award for the minimum accident. Union Road Transport and Highways Minister Nitin Gadkari has given the Transport Ministers Road Safety Award to Rajasthan Roadways for all-India level minimum accidents for 2019-20 and 2020-21 in the presence of Union Defense Minister Rajnath Singh.

## **Universal Health Care Scheme in Rajasthan**



The Congress-led Rajasthan Government presented in the state assembly the Budget for FY 2021-22, focussing on healthcare and agriculture sectors. State Chief Minister Ashok Gehlot, who also holds the finance portfolio, presented his first paperless budget, which saw him announcing various proposals in his speech that lasted for nearly three hours. Gehlot imposed no new tax and gave relief worth Rs 910 crore in the budget, which had health, agriculture and youths as the primary focus areas. He said his government would bring a Universal Health Care Scheme worth Rs 3,500 crore under which each family will get insurance benefit of up to Rs 5 lakh.

## **Difficult for India to Achieve Targets of SDG-12**

rive years into the implementation of Sustainable Development Goals (SDGs), the assessment of the progress in India shows, it is doubtful that India will achieve any of the targets of SDG-12, which is 'Responsible Consumption and Production.' In addition, the status of many of the indicators may further worsen by 2030, compared with 2015, due to the negative impact of the pandemic and various other reasons.



This was one of the major findings of a study done by CUTS International on SDFG-12 titled "Sustainable Consumption and Production—A Consumer Perspective". The study mainly looked at SDG-12 from a consumer perspective based on The United Nations Guidelines for Consumer Protection (UNGCP). The importance of studying and analysing the achievement of a country's progress under SDG-12 than any other goal was felt because of its interlinking nature with other goals. Almost all other goals are connected with SDG-12, thereby underlining that any progress in meeting Agenda 2030 by a country cannot be achieved without carefully approaching and addressing the concerns under SDG-12.

The key findings of this study by CUTS on SDG-12 were discussed and deliberated in the National Consultation organised by CUTS International in partnership with the Swedish Society for Nature Conservation (SSNC) in New Delhi on March 18, 2021.

During the inaugural session, Rene Van Berkel, UNIDO Representative, Regional Office in India, said, "SDGs are very interconnected. SGDs are like a dice with 17 sides, we cannot move on any side without moving the other ones, so one cannot just pick out anyone's goal without any action on others." Cheriyan expressed concern about how neglected SDG-12 is when compared to all other goals. He claimed that SDG-12 is an orphan goal, as the goal itself is a mixed bag with many of its targets outside the control of the Ministry of Environment.

Archana Datta, SWITCH-Asia RPAC Coordinator for India, UNEP, spoke on efforts, which are being currently taken under SWITCH Asia Programme to address this concern.

The consultation underlined the need for the centre to take the lead in adopting a green public procurement policy to send a strong message to the business community and create a solid thrust to expedite the not-so-active national ecolabel 'Ecomark'. Apart from sharing best practices from the project states, this consultation deliberated on various other topics like food loss, sustainable tourism, natural resource efficiency and many more.

t. Gen. Alok Kler, PVSM, VSM, is General Officer-Commanding in Chief, South Western Command, Indian Army headquartered in Jaipur. George Cheriyan and Amar Deep Singh had a meeting with him on January 11, 2021, to discuss the possibilities of collaboration for promoting cycle-friendly cities and road safety. He appreciated the efforts of CUTS to promote cycling not only as fitness but also as a mode of sustainable commute. He agreed to participate in CUTS platform and also suggested involving other concerned

government authorities as well.

### **CUTS Campaign Against Honking**

Jaipur holds a population of 3,653,927 and is a vehicular population of 2,249,000. At the moment, it is struggling with loud noises of horns. Such noises add to noise pollution and irritate road users, which often results in road rage.

When looking at other foreign cities, there is hardly a honking habit among drivers. While taking the example of buses, especially those operated by Rajasthan State Road Transport Corporation, it has been seen that buses are equipped with air horns, which use compressed air to create a loud noise. Big trucks and emergency services vehicles use air horns to alert other drivers to their presence, as do trains and ships. Air



horns are used at sports events since their volume level is high enough to be heard over loud audiences of fans. But when the normal city buses or the roadways buses use such horns, it becomes problematic, not only to other road users but also for the residents of those roads, from

where these buses ply.



There are regulations available in various laws under which these horns are strictly prohibited, but its compliance is almost negligible. The details of which are: Rule 5A (1) of the Noise Pollution (Regulation and Control) Rules, 2000; Section 194 F of the New Motor Vehicles Act, 2019; Section 190 of the Motor Vehicles Act, 1988; Rule 23 of the Motor Vehicles (Driving) Regulations, 2017; Section 268 (18) of Noise Pollution Control under the Indian Penal Code, 1860; Section 133 and 134 of Noise Pollution Control Under the Code of Criminal Procedure, 1973. As part of its

campaign outline, CUTS has started advocacy with authorities through research to find out the existing/available regulations in different country laws. Besides, CUTS will also use social media and networking for mass mobilisation under the campaign.
