Slow and Gradual Transition to Organic Farming Will Ensure Chemical-Free Farming in Rajasthan

Sustained growth is key to India's future, for which a reduction in chemical farming and a move from chemical to organic farming are challenging. To this end, we all need to become champions of reform and reduce the amount of chemical farming by moving towards organic farming. This was pointed out by Padma Shri award-winning farmer Jagdish Pareek. He added that Rajasthan, a state suffering from water shortages, needs technology and a traditional strategy to achieve our target without financial loss.

Pareek spoke as chief guest at the launch of a project named "Developing a Culture of Sustainable Consumption and Lifestyle Through Promoting Organic Consumption and Production and Adopting Sustainable Consumption Practices by Engaging Consumers in the State of Rajasthan, India" (ProScop). This project is being implemented in twelve targeted districts and all seven divisions of Rajasthan for five years (2022-2026).



In his opening remarks, George Cheriyan, Director, CUTS International, said that we should not think of shifting from conventional to organic farming overnight. He added that India ranks fifth (Australia 1st) in the area under organic certification and 1st in terms of the total number of producers. Cheriyan also highlighted that Madhya Pradesh has covered the largest area under organic certification, and Rajasthan earned the 2nd position, with 12 percent of the total organic certified land in the country. In the end, Cheriyan added, organic farming is a time-consuming process. There are several challenges, but we all need to move slowly and gradually and will achieve our target without facing any crisis issues.

Hanuman Mal Dhaka, Additional Commissioner, Department of Agriculture, highlighted the adverse effects of chemicals that farmers in farming use. Dhaka spoke explicitly about product demand and supply, stating that we need to raise public awareness about the hazardous effects of chemical products so that people recognise the value of organic items.

Organic farming can be a way to protect the climate, environment, and water, said A S Baloda, Director, Rajasthan Agriculture Research Institute (RARI). On a similar note, he emphasised the need for farmers to perform honestly in organic farming. Surendra Awana, a progressive farmer, spoke about innovative ways of farming and divergent practical methods that are helping farmers to take new initiatives to move towards organic farming.



CUTS Nominated to the Traffic Management Committee of Rajasthan

In Rajasthan, traffic management is becoming complex and challenging since the traffic volume is increasing and space on roads for traffic and vulnerable road users is shrinking year by year. As a result, in 2020, 9667 people died, and 16798 were injured in 19550 road accidents, as per the NCRB report. To address the menace of traffic mismanagement and ensure road safety, the Government of Rajasthan is taking appropriate measures from time to time. Recently the name of the Transport Department has been changed to Transport and Road Safety Department. George Cheriyan, Director, CUTS, who will be representing CUTS in the Committee, opined that the Government of Rajasthan had nominated *CUTS* as a Civil Society member to this committee for the next year.

The National Green Tribunal, Bhopal Bench, has asked the Rajasthan government to comply and follow the guidelines for the prevention of noise pollution issued by its Principal Bench, the Supreme Court and the Central Pollution Control Board. The direction was made in an application filed by CUTS regarding rampant noise pollution in the State, which majorly emanates from vehicles either through incessant use of horns or modified exhausts.

Now, COVID-19 has further pushed the country behind in reaching the UN Sustainable Development Goals (SDGs) and has caused widespread loss of livelihoods and incomes, threatening the food security, health, and nutrition of poor and marginalised people. This can be corroborated by the latest Global Hunger Index Report, where India has slipped to 101st position of 116 countries from its 94th position in 2020.

Earth Day 2022: India Must Invest in Effective Enforcement of Environment Laws

The 12th edition of the biennial Environment Performance Index (EPI Index 2020) released by the Yale University ranked India at 168th position among 180 countries in terms of environmental performance. In 2018, the country's rank was 177 with a score of 30.57 out of 100. India scored 27.6 out of 100 in the 2020 index. Such poor ranking is despite the country making many advancements in environmental law, which have flowed from the provisions of the Constitution that require the state and the citizens to protect the environment.



The right to life, guaranteed in the Constitution, includes the right to a healthy environment. When India established the National Green Tribunals in 2010, it

became the third country in the world after Australia and New Zealand to have a specialised forum for disposal of cases pertaining to environment. Yet, we are far behind in global rankings.

The Earth Day 2022 must be seen as an opportunity to address the shortcomings that stop it from performing better on key parameters. This year's theme 'Invest in Our Planet' not only means aligning our individual actions to make the earth more sustainable, but also about analysing how well the governments at the centre and states have invested for ensuring effective enforcement of our environmental regulations.

Food Processing Industries Ignore Consumer's Health Due to Fear of Economic Loss

Front of package labeling (FoPL) is one of the effective policy tools that can partially rebalance the unhealthy retail packaged food environment and aid consumers in making informed, healthier food choices. While several nations have implemented stronger regulations through the introduction of FoPL in food products and subsequently witnessed lower rates of non-communicable diseases (NCDs), no such restrictions exist in India. CUTS industry mapping study has revealed that food processing industries ignore consumers' health due to unwanted fear of economic loss.

World Consumer Rights Day, 2022

The United Nations Guidelines for Consumer Protection (UNGCP) were adopted by the United Nations (UN) in 1985. The guidelines were revised in 1999 and again in 2015 to ensure that they are up-todate and address the real challenges people worldwide face. The revised guidelines included a new section on sustainable consumption and e-commerce, financial services, other issues and implementation.

"Consumers from everywhere will benefit from digital financial services. Hence, digital financial services must be accessible, secure, confidential, and sustainable," said Pradeep S Mehta, Secretary General, CUTS in his opening address.

CUTS International organised the Conference on World Consumer Rights Day (WCRD) with the theme: 'Fair Digital Finance'. Mehta suggested that WCRD should be one of the UN Days and the Department of Consumer Affairs should be strengthened at the National, State, and District levels.



Deepak Saxena, CUTS, highlighted that consumer organisations come together to raise awareness of an essential issue to consumers worldwide each year. He discussed six consumer rights that are part of the Consumer Protection Act, 2019.

Munish P Kothari, former Regional Director of the Reserve Bank of India (RBI), agreed that consumers should be aware of their rights. Kothari mentioned that non-governmental organisations (NGOs) play a critical role in raising consumer awareness.

Furthermore, Abhishek Kumar, Indicc Associate, spoke about Fair Digital Finance from a gender perspective, focusing on self-help groups. He stated that 60 percent of the population in India does not have access to the Internet, and there is a need for more capacity building.

Manoj Meena, Assistant Professor, University of Rajasthan, spoke about fraudsters targeting developing countries. People attempt to purchase low-cost products with doubtful security, and device manufacturers also play a crucial role in developing low-cost, secure chips.

Meena claims that a consumer rights chapter should be included in the college curriculum, and young people should be aware of their consumer rights.

Rakesh Krishna Sharma, RBI, Regional Office, Jaipur, spoke about activities that the RBI and several banks are involved in. He said India is the number one country globally regarding digital transactions. We must be aware of fraud and take steps to stop it.

Amol Kulkarni, Director, CUTS International, moderated the opening session and proposed a vote of thanks. The Conference was attended by more than 35 participants representing the RBI, industry, academics, and civil society organisations (CSOs).

Efficient Water Management is the Need of the Hour

"There is a need for a regulatory framework and reforms for efficient water management in India," said Gopal Krishna Agrawal, Author of the Book "Water an element of life price sensitivity and consumption by the marginalised". He spoke in the webinar organised by CUTS to observe World Water Day 2022. He opined that currently, there are several conflicts about water, which are very important for public debate.

Bipul Chatterjee, Executive Director, CUTS, highlighted the relevance of the webinar topic and the gravity of the groundwater situation in our country.



Mathew Cherian, Chair, CARE India, spoke about how essential traditional knowledge is to recharge water. He stated that there is significant pressure on groundwater across the country, and reports are saying that states like Rajasthan would face a severe crunch in the coming years.

Shubha Ramachandran, Head, Water Team, Biome Environmental Trust, shared her experience from the perspective of an urban or urbanised context. She reminded us how people living in cities are unaware of where the water comes from and where the wastewater goes.

Joydeep Gupta, South Asia Director, The Third Pole, claimed that India is the largest user of groundwater in the world in irrigation, which is certainly not moving in a sustainable direction. During the discussions, the panelists also voiced the vital role of local governments in water management.

Mehta pointed out that CUTS has dealt with these issues for many years. He said a whole government approach is required as most issues cover various ministries other than just Water Resource Ministry. More than 50 participants attended the webinar.

Combating Child Labour in Rajasthan

CUTS, in partnership with World Vision India (WVI) and Vagdhara, launched the project entitled 'Strengthening Formal and Informal Systems and Structures as well as the Capacities of Vulnerable Children and Households to Reduce Child Labour in Banswara and Pratapgarh, Rajasthan' at Pratapgarh on March 22, 2022.

The project's objective is to reduce the incidences of harmful child labour by 50 percent by 2025 in Suhagpura block of Pratapgarh district and Ghatol block of Banswara district of Rajasthan. Sangeeta Beniwal, Chairperson of Rajasthan State Commission for Protection of Child Rights (RSCPCR), was the Chief Guest. She delivered the inaugural address and formally launched the project.



Prakash Chandra Sharma, District Collector, was the Guest of Honour. Charanjit Lal Meena, Additional Superintendent of Police, Pratapgarh, was a special guest. Around 70 participants attended, including Pradhans, Sarpanchs, other elected representatives, officials from various government departments and representatives from NGOs and CBOs of Pratapgarh district. George Cheriyan and Nimisha Sharma from Jaipur; Gauhar Mehmood from Chittorgarh; Kamlesh Kumar Jangid and Mohan Meghwal from Pratapgath attended the event.

CUTS Demanded Effective Implementation of Ecomark Scheme in India

CUTS observed Earth Day 2022 at the Mother Earth sculpture site at Jaipur on April 22, 2022 to demand an effective Ecomark in India. Ecomarks are important for promoting sustainable consumption and production policy that aims to reduce the negative impact of consumption and

production on the environment, health, climate, and natural resources.

Eco mark scheme was launched in 1991 by the Ministry of Environment & Forest, Government of India, to quickly identify environmentally friendly products. The label is awarded to consumer goods which meet the specified environmental criteria and the quality requirements of Indian standards. Ecomark is identified by the symbol of Matka (earthen pot).

The scheme has not been



able to take off as expected for several reasons, including the absence of support through government procurement. The government and concerned agencies need to implement the scheme effectively and create awareness to increase consumer demands. Neither producers nor consumers are aware of its existence or willing to go for this label.

For sustainable consumption to happen, the government need to ensure that the market provides consumers with sustainable choices that are reliable and trustworthy. Today, the market shelves are overtaken by-products that position themselves as 'sustainable', 'environment friendly', 'eco-friendly', 'Recyclable' etc. In actuality, they don't, and they are merely taking advantage of the changing consumer behaviour to push their sales. A reliable ecolabel is a must for consumers to ensure that the products
