Sustainable Consumption and Production:

A Consumer Perspective

In partnership with the Swedish Society for Nature Conservation (SSNC), CUTS conducted this study mainly looking at Sustainable Development Goal (SDG)-12 from a consumer perspective based on the United Nations Guidelines for Consumer Protection (UNGCP). In this context, two State Level Stakeholder Consultations were organised at Uttar Pradesh and Himachal Pradesh, respectively.

Uttar Pradesh

Uttar Pradesh's step to achieve SDGs means a lot to India, as the State has the largest population in India. Therefore, Uttar Pradesh must develop effective methods for implementing, monitoring and measuring the progress of SDGs.

Learning, sharing and networking should be promoted among like-minded stakeholders across the State and beyond. These were some of the main highlights from State Level



Stakeholder Consultation organised by CUTS in collaboration with Consumer Guild, Lucknow, UP at Lucknow on July 29, 2021.

Anand Mishra, Senior Officer from Department of Planning, Uttar Pradesh, said that there is an absence of an effective monitoring and data collection framework for SDG 12. Hence, efforts are being initiated by the Government of Uttar Pradesh. A K Gupta, Additional Director, Regional Centre for Urban and Environmental Studies, discussed the best practices on sustainable consumption in Chhattisgarh and Jharkhand.

Manjul Mishra, Assistant Director, Directorate of Environment, Uttar Pradesh, highlighted the progress of SDG 12 in the State. The consultation saw participation from various government departments, organisations working on sustainable consumption and consumer protection from Uttar Pradesh.

Himachal Pradesh

Himachal Pradesh can improve its performance on SDG-12 by documenting the best practices of different sectors and departments. The Government of Himachal Pradesh has constituted a task force on SDGs by including 15 government departments to document its best practices to improve its

ranking further.

Himachal Pradesh must develop effective methods for implementing, monitoring, and measuring SDGs' progress. These were the important highlights from State Level Stakeholder Consultation organised by CUTS in partnership with the Planning Department, Government of Himachal Pradesh and Plan Foundation at Shimla on August 18, 2021.

Akshay Sood, Secretary, Department of Finance, Himachal Pradesh, stressed on the need for effective monitoring and data collection framework for SDG 12. He highlighted government's milestones and strategy to achieving SDG12.

Basu Sood, Advisor, Department of Planning, Himachal Pradesh, highlighted that consumers and corporates are important drivers of sustainable consumption and production and play a critical role in long-term growth.

Around 15 departments, including Environment, Urban Development, Tourism, Forest, Education, Medical and others, shared their department-specific progress and programmes related to the SDG12.








Grahak Sahayta Kendra, Jaipur

It is only in India that a whistle-blower and a crusader, whose honesty, integrity and brilliance have saved the country billions of dollars, would be demonised when alive and recognised as the 'father of Infrastructure' when he is no more. The people of India, who are the biggest beneficiaries of his work, remain clueless about his contribution.

As an IAS officer, he worked within the system and fought his battles for the nation mainly from the inside. In the process, he had to give up the opportunity for plum postings and post-retirement sinecures that are the primary focus of most senior bureaucrats. It is important to put Gajendra Haldea's (1949-2021) contribution to the nation in perspective and his brother Prithvi Haldea has done an excellent job of collating all his work and more at http://www.gajendrahaldea.in/.

His enormous body of work included drafting several key national and state legislation, such as Foreign Exchange Management Act, 1999, The Electricity Act, 2003, and three draft legislations covering regulatory reforms, public procurement and the Public Contracts (Settlement of Disputes) Bill, 2014, as well as the innumerable model agreements for various infrastructure projects are the most important.

Inculcating a Culture of Safe Food Practices in Rajasthan

CUTS launched a project on 'Safe Food Practices in Rajasthan' to increase awareness among rural masses on hygienic and clean food. It also aims to promote food safety awareness building, protection from contamination, COVID 19 and healthy food practices among the community.

This CUTS initiative will be instrumental in creating a model of 'Behaviour Change Communication' regarding good food hygiene, preventing food-borne illness, diarrhea and promoting a healthy lifestyle among communities in selected 12-gram panchayats in the targeted two districts of Chittorgarh and Bhilwara.



CUTS organised a Launch-cum-Training of Trainers (ToT) programme organised to kick start a three-month campaign at Chittorgarh on July 06, 2021. In a run-up to it, the second ToT was conducted on July 07, 2021 at Bhilwara. During the period, 12-gram panchayat level awareness meetings with women and adolescent girls; and four block level awareness meetings with children were organised.

The campaign focuses on the entire chain of food business operators, viz. retail food establishments, food service/delivery/takeaways, and food handlers like women who cook food at home and small street food vendors in selected districts.

Ensuring Road Safety on the Streets through Speed Management

webinar was organised on the occasion of the UN Global Road Safety on May 20, 2021. UN Global Road Safety Week is celebrated every two years. The theme of this year's week is Streets for Life and based on the Stockholm Declaration of 2020, advocating for 30 km/h speed, where people and vehicles mix.

Nalin Sinha, Country Representative, Global Health Advocacy Incubator (GHAI), India, said that evidence and policy reform from several countries suggest that road crash injury and death can be prevented or reduced significantly. Hence, there is a need for appropriate legislation backed by effective enforcement.



Bhargab Maitra,

Professor, Civil Engineering, IIT Kharagpur, spoke about the Speed Facility Development in India and underlined the importance of traffic accessibility functions to ensure road safety.

Gaurav Hariom Gupta, Deputy Secretary, Ministry of Road, Transport & Highways (MoRTH), Government of India, acknowledged that data collection of road accidents had become an issue and MoRTH is working on this area. An integrated Road Accident Database is being developed, which will enable the collection of accident data on the spot. This will help in analysing the causes of road accidents and help reduce fatalities. This real-time data collection is already implemented in six states.

T Elangovan, Executive Director, Kerala Road Safety Authority, Government of Kerala, spoke about speed control and management-related measures taken by Kerala.

Virendra Rathore, District Transport Officer Bhilwara, Rajasthan, spoke about the key provisions of Government of India's speed notification of 2018, Indian Road Congress-00 provisions, Speed Alarming system, Crash Data Retrieval systems, Speed Limit Display System, Section 112, and 183 related provisions of MVA Act, 2019.



Safe Food Now for a Healthy Tomorrow

(World Food Safety Day 2021)

The World Food Safety Day (WFSD) aims to draw attention and inspire action to help prevent, detect and manage food-borne risks, contributing to food security, human health, economic prosperity, agriculture, market access and tourism.

This year's theme, 'Safe food today for a healthy tomorrow', stresses that the production and consumption of safe food have immediate and long-term benefits for people, the planet and the economy. Recognising the systemic connections between the health of people, animals, plants, the environment and the economy will help us meet future needs.

Food safety is a shared responsibility between governments, producers and consumers. Everyone has a role to play from farm to table to ensure the food we consume is safe and healthy. Through World Food Safety Day, WHO works to mainstream food safety in the public agenda and reduce the burden of foodborne diseases globally. Food safety is everyone's business.



Earmarking on the importance of the day, CUTS observed World Food Safety Day on June 07, 2021, in a virtual mode by displaying posters with slogans relevant to the issue on social media. The team also participated in the Twitter Chat hosted by UN Statistics on June 01, 2021.

Rules Should Stick to Consumer-Facing Concerns

George Cheriyan, Deepak Saxena and Simi TB attended a CUTS Roundtable on Proposed Amendments to the Consumer Protection (E-Commerce) Rules, 2020 on July 02, 2021, and other CUTS staff. Moderating the session, Pradeep S Mehta, Secretary General, CUTS, set the tone by flagging how adding Platform-to-Business regulatory elements could disturb the simplicity of the consumer protection regime.

Saroja S, Director of Chennai-based Citizen consumer and civic Action Group (CAG), instead wanted to emphasise "factors like sustainable consumption, packaging and carbon footprints, while building awareness about such green initiatives through consumer labelling."

Surendra Kanstiya, former Chairman of Mumbaibased Consumer Guidance Society of India, highlighted that "the proposed amendments are poorly drafted hence affecting user-readability and implementation."

Ujjwal Kumar, Policy Analyst at CUTS International, was not satisfied with the rationale provided by the government for the proposed amendment within a year of the notification of the Consumer Protection (E-Commerce) Rules, 2020.

Gowree Gokhale, Partner, Nishith Desai Associates, explained how bringing elements to 'encourage free and fair competition in the market' into the proposed amendments goes beyond the mandate of its empowering provision in the parent Act (i.e. Section 94 of Consumer Protection Act, 2019).

While echoing Gokhale's sentiments, Vivan Sharan, Partner, Koan Advisory Group, identified these proposed amendments as a "disguised industrial policy". He stated that "if we need to create a space where local retailers can flourish, then the policy decision should leverage what the large enterprises have to offer, rather than to chew them away."

Cheriyan, highlighted that the regulatory overlaps must be mitigated, and the focus should remain on 'consumers' in consumer protection legislation.
