



# **Project Status Report**

**1 Project Title**: Giving the Poorer Consumers Greater Voice in India (ProVoice)

# **Objective:**

To make awareness of low-income consumers using safe and sustainable products and improving their health and wellbeing, as well as promoting healthy home in their children and families.

**Area of Intervention:** Eral and Netwalgarh Pachli villages in Chittorgarh district of Rajasthan.

- 3 Activities Done During the Period (In Detail):

#### 3.1

## 10.9.2019 Training of Staff Members, CHD Office

On 10 October 11 am, in the meeting hall of the office, Nimisha Gaur explained in detail the activities of CHD's Pro-Voice project to the members conducted from September to December. She said that 4-5 products have to be selected which are harmful to health and identify safe and sustainable products and identify the manufacturers and suppliers in their place. 3 products to choose from are LED bulbs, washing powder and stove. Discussion on how many activities to do in the project and how to do it was held.

#### 11.9.2019 Guest Lecture, CHD Office

On September 11, a meeting of Swabhiman Wheat Processor Company Ltd was held at CHD office. In the meeting, 12 people from Netawalgarh Pachli and Eral village participated. Giving information about the Pro-Voice project in the meeting, Mohan Meghwal said that under the project, various activities will be conducted in Netawalgarh and Eral to make consumers aware of their rights. To make people aware of the diseases due to the smoke emanating from the use of traditional stoves used in homes and to make people aware about use of smokeless stoves. Also, about using safe electric quality products and using LED bulbs. Training women on making washing powder.

## 26.9.2019 Guest Lecture, CHD Office

On September 26, a district level workshop was organized under the pro-organic project at CHD. 17 people from Netawalgarh Pachli and Eral villages participated in the workshop. Giving information about the Pro-Voice project at the meeting, Madan Giri Goswami said that under the project, various activities will be conducted in Netawalgarh and Eral to make consumers aware of the rights, including street play, puppet show, awareness meetings, school rally with children, community meetings etc. Also, consumers will be made aware on consumer rights and responsibilities. In the third phase of the project, the demand for the use of safe and sustainable products will be increased as well as a dialogue will be made with the manufacturers and suppliers of the products so that the consumers can get quality

products on time. Information about district consumer forum for complaint redressal and CUTS was also given.

# 5.10.2019 Puppet Show and Community Meeting-Eral

On 5 October 2019, a community meeting and puppet show was organized for consumer awareness on bus stand at 12 noon in Eral village in which 31 consumers including 2 women consumers participated. Mohanlal Meghwal, Shyamlal Damor and Surajmal Makwana participated as CUTS representative. In the program, consumers were made aware of the consumer rights and responsibilities through a puppet show. Information was given about contacting the District Consumer Forum and CUTS Office in case of any problem in the products. Several times consumers complain that there is no one to redress the problem about the product and they are made to run from pillar to post. Electricity consumers said that arbitrary amount is being collected by the power companies from the electricity consumers and the company does not listen even if someone complains. They were informed that complaint should always be done in writing or using the toll-free number operated by the company so that your complaint is recorded. This will increase accountability of the company. In this meeting, Mohan Lal Meghwal informed about the CUTS project aims and objectives to raise the voice of poor consumer in Netawalgarh and Eral. 'Mera Haq, Mera Adhikar' calendar and pamphlets were also distributed.

# 5.10.2019 Puppet show and Community Meeting-Netawalgarh

On October 10, 2019, a community meeting and consumer program for consumer awareness was organized at Ramdevji temple in Netawalgarh village at 5 pm in which 29 consumers including 5 women consumers participated. Mohanlal Meghwal, Shyamlal Damor and Surjmal Makwana participated as CUTS representative. In the program Rameshwarlal Garg made consumers aware of consumer rights and responsibilities through puppet show. Information was given about contacting the District Consumer Forum and CUTS Office in case of any problem in the products., not hearing the consumer or violating the rights of the consumer by any product vendor. Several times consumers complain that there is no one to redress the problem about the product and they are made to run from pillar to post. Electricity consumers said that arbitrary amount is being collected by the power companies from the electricity consumers and the company does not listen even if someone complains. They were informed that complaint should always be done in writing or using the toll-free number operated by the company so that your complaint is recorded. This will increase accountability of the company. In this meeting, Mohan Lal Meghwal informed about the CUTS project aims and objectives to raise the voice of poor consumer in Netawalgarh and Eral. 'Mera Haq, Mera Adhikar' calendar and pamphlets were also distributed.

# 6.10.19 Snake Ladder Game and Quiz with Kids - Eral

On October 6, a snake and ladder game with children and quiz competition was held near the Charbhuja temple in Eral village, in which 12 children participated. Suraj Makwana and Mohan Meghwal participated from the CUTS. Surajmal told the children about the rules of the game. They were told to read the printed words on the banner and advance their pawns for each good work or otherwise snake will bit for bad works. After this, Mohan Meghwal asked questions related to children consumers. In this game, first three winners were distributed with LED bulbs and pens.

# 7.10.2019 Women's Meeting, Snake Ladder Game and Quiz, Eral

On October 7, 2019, women's meet, snake-ladders game and quiz contest were organized in 13 Balai Mohalla in Eral by the CUTS. Shyamlal Damor and Govardhan Lal participated as CUTS representatives. In the meeting, Govardhan Lal Pareek said that we use a variety of unsafe products in our homes every day, which can cause harm to the family due to chemical based washing laundry powder, traditional stove used in the house and traditional bulbs etc. Instead of such products, people should use products that doesn't affect health of family in any way. People were made aware of the use of safe products by CUTS and consumers' access to safe products is being made easier.

After this Shyamlal told the rules of Snake-Ladders game and women were made to play the game. In the game, the first, second and third winners were given bags as prize. Subsequently, a consumer related quiz contest was organized.

# 7.10.2019 Meeting with Children, Snake Ladder Games and Promotions, Eral

On 7 October 2019, Balai Mohalla in Aral organized a meeting with children through cuts, snake-ladder game and competition contest in which 11 children participated. Shyamlal Damore and Govardhan Lal participated as Cuts representatives. In the meeting, Govardhan Lal Pareek said that we use a variety of unsafe products in our homes every day, which can cause any harm to the family such as chemically washed laundry powder, the traditional stove used in the house and yellow. Bulbs etc. Instead of these products, such products should be used which do not have any bad effect on our family. To make people aware about the use of safe products by CUTS, programs are being organized in many villages and schools and consumers' access to safe products is being made easier. After this Shyamlal told the rules of Snake Siddhi game to the children and the children were made to do the game. Children in the first, second and third games were awarded LED bulbs. Subsequently, a consumer related promotion was organized.

# 9.10.2019 Women's Meeting, Snake-Ladders Game and Quiz, Netawalgarh Pachhli

On October 9, a women's meeting was organized at the Balaji temple in Rajput Mohalla of Netawalgarh Pachhli village. 20 women attended the meeting. From CUTS Mohan Meghwal and Surjmal Makwana were representatives. At the beginning of the meeting, Mohan Meghwal gave introduction and informed about the aims and objectives of the project. Surjmal Makwana said that women do all the household work and work more than men, so women need to be more aware of consumer related information. During the meeting, women were informed about the traditional stove used in the home. He said that the smoke emanating from traditional stoves cause many diseases and cause damage to the environment also. So, we should use smokeless chulha. After this, women were made aware of consumer rights and responsibilities through the Snake-Ladder game. At the end of the game, women were asked to participate in quiz contest and the first three winners were given the bags as prize. Children and women have a greater role in this project. People were informed that if they find any fraudulent product then they can contact CUTS.

The women told that they attend gram panchayat but their voice is not heard. They said that they will now go together to let their voice heard. They said that they will also take advantage of the schemes run by the government. Women told that the activities that have taken place today should continue to happen as they have received many information related to consumers.

In the end, vote of thanks was given by Mohan Meghwal.

# 9.10.2019 Women's Meeting and Quiz Competition, Eral

A women's meeting was held on October 9 at Bairava locality in Eral village. 19 women attended the meeting. Gayatri Mod and Shyamlal Damor from CUTS participated. Gayatri Mod gave introduction at the beginning of the meeting and information was given about the goal and purpose of the project. Gayatri Mod said that women need to be more aware about consumer related information because they do more shopping. Children and women have a greater role in this project. As consumers, we also have some rights and responsibilities which should be taken into consideration while purchasing services and goods.

The aim of the project is to change the behavior of the consumers towards the purchase of safe and sustainable items, as well as to raise awareness about the effects of clean water, safe electricity and indoor pollution so that healthy home environment be provided to children to live.

CUTS conducted a sampling survey of water and indoor pollution in your village, which found that drinking water in the village is contaminated. The water is good for drinking and the pollution inside the houses is excessive, which is causing adverse effects in the family and especially children. After this Gayatri Mod answered the questions related to the conscious consumers. Women who gave correct answers to the questions were given away bags as prize.

Giving examples, women said that many times we purchase washing powder which contains salt and many times a powder causes burning sensation in the hands.

# 9.10.2019 Community Meetings and Puppet Shows - Eral

A community meeting was held on October 9 at Bairava Mohalla in Eral village. 28 women, men and children participated in the meeting. Gayatri Mod, and Shyamlal Damor participated from the CUTS. Gayatri Mod gave introduction at the beginning of the meeting and information was given about the goal and purpose of the project. Gayatri Mod said that the consumer needs to be more aware about the shopping related information because as a consumer we also have some rights and responsibilities which should be taken into consideration while purchasing services and goods.

The aim of the project is to change the behavior of the purchasers towards the purchase of safe and sustainable items, as well as to be aware of the effects of clean water, safe electricity and indoor pollution so that healthy home environment be provided to children to live.

Puppet artist Rameshwarlal Garg conveyed the rights and responsibilities of consumers through a show. Giving an example, he explained that consuming headache pill without seeing expiry date can worsen health and treatment cost can be high. However, if consumer understands his responsibilities right then such a condition can be avoided.

Putting light on the purpose of the project, he said that this project is to raise awareness among consumers about the use of safe and durable products. Healthy families should be encouraged so that safe houses can be constructed for children to live. Under this pilot project, this project is operated for safe electricity, clean water and indoor pollution in two villages of Eral and Netawalgarh.

Shyamlal Damor said that we must take the bill of goods while shopping. The consumer should buy product only after looking at the necessary information like company name, production date, expiry date, weight and quality etc. If there is any kind of issue, consumer should immediately contact the District Consumer Forum or CUTS.

# 10.10.2019 Bal Panchayat Meeting, Snake Ladder Game and Competition-Netwalgarh

He said that we should use LED instead, which will reduce our house bills and also will not cause any harm to the body.

Nathulal Purbia & Party gave information about consumer rights and responsibilities through folklore. It was told through the song that while buying goods, taking the bill is also the right of the consumer. Any kind of loss can be avoided by taking bill of the product. For any kind of fraud, consumer should check the bill then he can seek compensation from shopkeeper. Even after this the problem is not resolved, then contact the District Consumer Forum or CUTS.

We should use advanced stove which emanates very less smoke, takes less cooking time and less wood. Such stoves are now being made available to you by CUTS, but in the future, if there is more demand for it, then people can get it themselves. If there is any demand then people can directly contact Sidha Company who will provide stove. Regarding clothes washing powder, it was informed that training will be provided on some clothes washing powder to the women of the village so that they can make powder here and sell it in the village and nearby villages. It will also generate employment. It was informed that all of us should use LED bulbs in our homes so that our electricity bill will also be reduced and there will not be any bad effect on the eyes.

During the meeting, women were shown advanced stove and the benefits of this stove were given to the women.

The purpose of the meeting and the purpose of the project was explained in detail by Gayatri Mod. She said that we must take the bill while making any kind of purchase. Taking a bill is a consumer's right. We can save ourselves and our family from being cheated by taking the bill. We should always buy only branded items. Mohanlal said that some people in your village are being given advanced stove by CUTS and a demo will be shown. Anyone can buy it. This stove reduces smoke and uses less wood. If you need it in future, you can get it from Govind Vaishnav of your own village and appointed him as a supplier. He said that we must take the bill of goods while shopping. The consumer should buy only after looking at the necessary information like company name, production date, expiry date, weight and quality etc. If there is any kind of issues, you should immediately contact the District Consumer Forum or CUTS.

## 12.11.2019 Formation of Consumer Protection Group - Netawalgarh

On 12 November, a community meeting was organized at 6 pm in the house of Leela Jain of Netawalgarh Pachhli in which youth and women participated. The purpose of the meeting is to constitute a consumer protection group in the village.

Madangiri Goswami and Govardhan Pareek participated from CUTS. Everyone gave their introduction in the meeting and Madangiri Goswami gave detailed information about the purpose of the group, members, methodology and how the consumers will get support. After this, the attendees were asked to select the Chairman, Treasurer, Secretary and members in the group. With the consent of all, Manjudevi Bohra, a village-educated woman, was appointed as the President of the Consumer Protection Group, followed by Govind Vaishnav for the post of Secretary and Saddam Hussain for the post of Treasurer. All the remaining 14 were appointed to the member post.

After this, with the consent of all, it was decided to hold a meeting every month. It was decided organise the meeting at Leela Jain's house at 8 pm on the 12th of every month.

Govardhan Lal said that a register has been given to the consumer protection group in which the discussion of the meeting of every month will have to be recorded. Issues during the meeting will have to be decided and implemented. No decision will be taken by any one person. If any problem of a consumer comes during the meeting, the work of writing a proposal through letter to the concerned department will be done by the secretary, a copy of which will also have to be sent to the CUTS office. During the meeting, a banner of consumer protection group will be installed, which will be provided by CUTS.
